Ref:- This is in continuation of this office letter No. 7601-7699/DUI/DS dated 27.10.2016.

You are again requested to brief and sensitise the students of your department regarding the rules and norms of condonation of shortage of attendance, so that they fulfill the requirements as communicated to you vide letter under reference.

The departments are to follow the process listed below for condonation of shortage of attendance of the students of even semester:-

- 1. Attendance of the students be counted from the date of start of teaching of the semester.
- 2. Sportsperson to be given concession for attending camps / participation in tournaments.
- 3. Teachers to submit **paper-wise** cumulative attendance with shortage at 75% (or as per the requirement of the regulatory body, if any), latest by 5th of every month to the Chairperson.
- 4. The Department to upload the **paper-wise** cumulative attendance on the online Notice Board of the department latest by 15th of every month and send a copy of the same to the office of the DUI for information.
- 5. All the cases of shortage of attendance, complete in all respect, must reach the office of the DUI, at least one week before the commencement of end-semester examination. Shortage of the attendance is to be calculated and reported to us **paper-wise**.

Chairpersons to ensure that the student(s) who have already claimed the ad-hoc benefit of 10% for participation in cultural / extra-curricular activity in the odd semester 2016, do not get the benefit of participation in the current semester.

The revised proforma for submitting the cases of condonation of shortage of attendance is enclosed as **Annexure A**.
