## Subject:- Board of Control for the year 2020.

The Senate at its meeting held on 08.12.2007 (Agenda Item 64) has amended the Regulations 4.1 at page 64 PU Cal. Vol. II 2007 and Regulations 3, at page 150, Cal. Vol I, 2007 in anticipation of approval of Govt. of India / Publication of Govt. of India Gazette, as under :-

The Syndicate shall, from time to time, appoint Boards of Control for the various teaching departments of the University. Such boards are appointed in January every year consisting of :-

1. The Chairperson / Head / Director of the University Department / Institute / Centre in the subject concerned as an ex-officio member;
2. Not more than five Professors and five Associate Professors of the Department / Institute / Centre by rotation according to seniority;
3. Two Assistant Professors of the Department / Institute / Centre on the recommendation of the Chairperson / Head of the Department / Institute / Centre by rotation, according to Seniority; and
4. In the case of Honours School Department, one teacher from the department in each subsidiary subject of the school.

The list may be sent to this office by $\mathbf{1 1}^{\text {th }}$ of December, 2019, to seek necessary approval of the appropriate authority for the constitution of the Board of Control. It may be noted that :-

- Faculty members retiring during the year would automatically cease to be members of Board of Control on the date of their superannuation.
- Faculty members who are on long leave during the year may not be included in the list of Board of Control.
