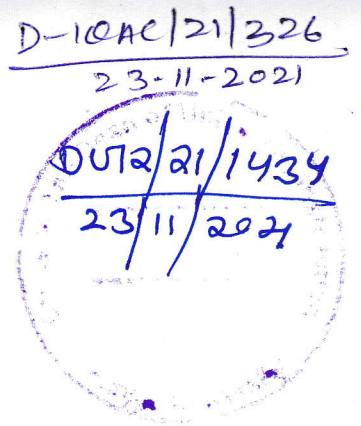

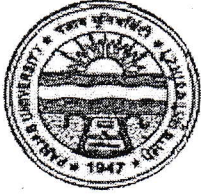

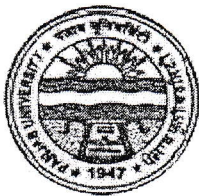
- Safety and security

In case, the Annual Gender sensitization action plan exists already, the same should be provided to IQAC for the year 2015-16 to 2020-21 alongwith a writeup describing gender equity & sensitization in curricular and co-curricular activities and facilities for women on campus. A web page on PU website should be created for specific facilities provided to women and link of webpage should be provided to IQAC. The criteria metric for above requirements is annexed herewith for your reference please.

**Subject: Details for the parameter of Disabled-friendly, barrier free environment in Panjab University**

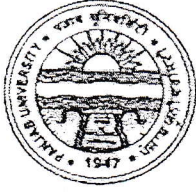
Dear Sir,
